## Location & Schedule

The Bozeman Public Library is once again the featured venue for the Sweet Pea Juried and Open Art Shows! Both shows will be displayed in the library's central hallway between Thursday, July 31<sup>st</sup> and Friday, August 29<sup>th</sup>. All artwork may be viewed during the library's normal business hours, which are Monday - Thursday, 10 a.m. to 8 p.m., and Friday - Saturday, 10 a.m. to 5 p.m. All artists and the public are invited to the opening reception on Thursday, July 31<sup>st</sup> at 6 p.m., in the Public Library's Large Conference Room.

## Eligibility

The Juried & Open Art Shows are open to all artists. **Artists may only enter one piece of work. In an effort to allow greater participation in the shows, hanging artwork shall not exceed the size of 4 feet x 4 feet (48 inches x 48 inches).** Only original artwork designed and executed within the last two years, and not previously shown in past juried shows, is eligible for the Juried Show participation. The Open Show is a non-juried and non-competitive exhibition. Artwork in any media is acceptable, but acceptance is also conditional upon examination for extreme fragility or size. **Please keep in mind that artwork will be located in an area heavily frequented by the public. Artwork also must be finished and ready for professional hanging.** If artwork requires special handling, it must be accompanied by the artist's written instructions. All artwork must remain on display for the duration of the exhibition.

## Delivery & Deadlines

**Hand Delivered:** Artwork must be hand delivered to the Bozeman Public Library, 626 East Main Street, Bozeman, on Monday, July 28<sup>th</sup> between 12 and 5 p.m. Application form and entry fee will be collected at that time, as well as the optional artist statement. If the artist is unable to hand deliver on July 28<sup>th</sup>, the work must be shipped, or special arrangements must be made with the Art Show Chair.

**Shipped:** Artwork being shipped must be sent prepaid in appropriate reusable containers to the Sweet Pea Office, Attn: Art Show, PO Box 1015, Bozeman, MT 59771. All shipped pieces must arrive no later than Monday, July 21<sup>st</sup>. Application form and entry fee must be included. Artist statements are optional, but encouraged. Shipped artwork not accompanied with return postage will be disposed of at the discretion of the Art Show Chair.

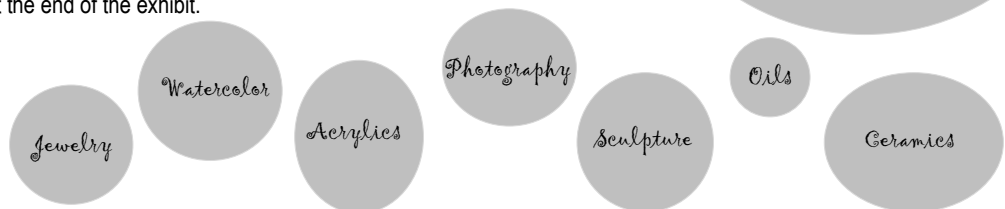

## Notification of Acceptance

Notice of acceptance into the Juried Show will be mailed to all artists on Tuesday, July 29<sup>th</sup>. Artists that give email address will be contacted by email as well. All accepted artwork must be on display for the duration of the exhibition. In the event a piece is not accepted for the Juried Show, the artist may have it automatically transferred to the Open Show by checking the appropriate box on the entry form.

## Sales

Sales are encouraged upon the artist's request. Sweet Pea will handle transactions, retain a 30% commission on all works sold, and disperse the remainder to the artist by check. Artwork is not available to the purchaser at the end of the exhibit.



## Insurance

Artwork is insured (\$5,000 maximum per piece) by the Sweet Pea Festival for the duration of the show, but will not be insured before or after the exhibition. Neither Sweet Pea nor the Bozeman Public Library are responsible for work during transit or for work not picked up by specified dates and time allotments.

## Return of Work

**Unaccepted artwork for the Juried Show, not transferred to the Open Show,** must be picked up at the Bozeman Public Library on Monday, August 4<sup>th</sup> between 12 and 5 p.m.

**Accepted Juried Show & Open Show entries** must be picked up at the Bozeman Public Library on Saturday, August 30<sup>th</sup> between 12 and 5 p.m.

**Shipped artwork** will be returned prepaid by the artist at the close of the exhibition. Failure to include return postage may result in the loss of your work. Please specify carrier and shipping instructions. If new crates are required for shipping, the artist will be charged for repackaging.

**Work not picked up or claimed by Saturday, August 30<sup>th</sup> will be stored at the Sweet Pea Office and assessed a \$5.00 per/day charge in storage fees to be paid by the artist to the Sweet Pea Festival. Work not claimed by Friday, September 26<sup>th</sup> will be disposed of at the discretion of the Sweet Pea Art Show Committee.**
