EVENT DATES:

Thursday, July 28, 5pm-7:30pm - Hand deliver artwork to the Conference Room in Bozeman Public Library.

Friday, July 29, 11am-3pm - Additional day to deliver artwork.

Monday, August 1, 11am-7:30pm - Artists notified by Sunday, July 31, must pick up non-selected artwork.

Thursday, August 4, 6pm-8pm - Opening Reception to the public in the Community Room of the library.

Friday, August 26 - Sweet Pea Festival Art Show ends.

Saturday, August 27, 10am-5pm - Pick up your exhibited artwork in the Bozeman Public Library atrium.

ELIGIBILITY:

Only ONE ORIGINAL *hanging* entry per applicant in any medium: Artist Statement is not required. Two-Dimensional or Three-Dimensional artwork must be delivered properly **labeled** (cut and attach slip of paper from entry form) with **entry form and non-refundable \$20 fee**. More entry forms available online at www.sweetpeafestival.org.

Recent artwork: Created within the last TWO YEARS and not previously shown at the Sweet Pea Festival Art Show.

Hanging 2-D & 3-D size cannot exceed: 3 ft. x 4ft. (36" x 48") or must be within this area.

Professional hanging quality: Framed/Staple-free edge (canvas), or sculptural forms not designed for frames, must be excellently finished off with wire or D-rings that will hang on a cable ratchet hook. Unusual installations accompanied with written instructions.

CATEGORIES & AWARDS:

Juried artwork: Notice of acceptance will not be sent out. Awarded six prize ribbons: First Place: \$350, Second Place: \$250, Third Place: \$150, Honorable Mention to 3 artists: \$75.00 each person. There will also be the People's Choice Award: Special ribbon.

Open artwork: Non-juried, subject to evaluation, and qualifies for the People's Choice Award.

OTHER TERMS & REQUIREMENTS:

Sales: Encouraged but not mandatory. Sweet Pea will handle all transactions, and after specified donated percentage by artist's request is taken out, the remainder will be dispersed by check.

Right of refusal: Artwork upon delivery that conflicts with the standards set forth by the Sweet Pea Festival and library (i.e. not child friendly--violence and nudity), as well as, artwork not able to be exhibited in a safe, practical manner, will not be accepted. **Please keep in mind that the artwork will be located in an area heavily frequented by the public and will not be monitored by security.**

Insurance: Limited nominal insurance is provided for artwork and exhibitors are expected to provide additional insurance if desired. Neither the Sweet Pea Festival nor the Bozeman Public Library are responsible for artwork during transit or artwork not picked up by specified dates and times.

Shipping: Entry form and fee must be included. Shipping must be prepaid and sent in highly durable, reusable containers to: Sweet Pea Office; Attn: Art Show; PO Box 1015; Bozeman, MT 59771. Failure to **include prepaid return postage** with your shipped entry will result in the disposal of your artwork. Please specify carrier and shipping instructions. **Deadline for exhibit: Wednesday, July 27.**

Art retrieval: Artwork not picked up will be charged a \$5.00 per day storage fee at the Sweet Pea Office and will be paid by the artist to the Sweet Pea Festival. After Friday, September 23rd, the artwork will be disposed of. **SWEET PEA DOES NOT CLAIM ANY RESPONSIBILITY FOR ARTWORK NOT PICKED UP BY THE SPECIFIED TIMES.**

Artwork must remain until the end of the show.

I have read and agree to all the specified terms set forth by the Sweet Pea Festival. I affirm that submitted artwork is original and produced solely by myself, the applicant. I further release the Sweet Pea Festival and all of its duly appointed representatives of all liability and responsibility for any injury, damage, or loss sustained by works of art before or after the Sweet Pea Festival Art Show. I understand that the Sweet Pea Festival reserves the right to remove any artwork that does not meet the requirements or standards set forth. In consideration of the Sweet Pea Festival's acceptance of my entry form, I agree to accept all decisions of the Juror and persons involved as final.
